Notice is hereby given that the **48th Annual General Meeting (AGM)** of Somany Ceramics Limited will be held on **Friday, the 2nd September, 2016 at 10.30 A.M. at LakshmiPat Singhania Auditorium, PHD Chamber of Commerce and Industry, PHD House, 4/2, Siri Institutional Area, August Kranti Marg, New Delhi -110 016.**

Pursuant to Section 91 of the Companies Act, 2013, the Share Transfer Register will remain closed from **23rd August, 2016 to 2nd September, 2016** (both days inclusive) for updation of Register of Members and to determine the names of the Members who will be entitled to receive dividend, if approved at the AGM.

Pursuant to the provisions of Section 108 of the Companies Act, 2013, read with Rule 20 of the Companies (Management and Administration) Amendment Rules, 2015 and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is pleased to provide its Members the facility to exercise right to vote by electronic means from a place other than the venue of AGM (**'remote e-voting'**) with respect to ordinary and special business to be transacted as set out in the Notice of AGM dated 21st May, 2016.

All the Members are further informed that:

- a) The Company has dispatched the Annual Report 2015-16 and Notice of AGM alongwith attendance slip, proxy form and a separate letter addressed to Shareholders individually inter-alia containing User ID and password on 4th August, 2016 to those Members whose name appears in the Register of Members as on 22nd July, 2016 in physical mode to their registered address by courier who have not registered their email id with the Company/Depository Participants (DP) and electronically to those members who have registered their email address with the Company/DP's, as the case may be. These documents can also be downloaded from the website of the Company i.e. www.somanyceramics.com and website of CDSL i.e. www.cdslindia.com.
- b) Members holding shares either in physical or dematerialized form and whose names appear in the Register of Members/Beneficial Owners as on the cut-off date i.e. **26th August, 2016**, may cast their vote electronically on all the business as set out in the Notice of AGM, through electronic voting system of Central Depository Services (India) Limited (CDSL).
- c) Any person who becomes Member of the Company after the dispatch of the Notice of the AGM and holding shares as on the cut-off date i.e. 26th August, 2016, may obtain user ID and password for remote e-voting by writing to the Registrar and Transfer Agent of the Company at its email id viz. mdpdlc@yahoo.com.
- d) The remote e-voting facility shall commence on Tuesday, **30th August, 2016 from 9.00 a.m. (IST)** and ends on Thursday, **1st September, 2016 at 5.00 p.m. (IST)**. The remote e-voting shall not be allowed beyond the said date and time.
- e) Members who have cast their votes by remote e-voting prior to the AGM, may attend the AGM, but shall not be entitled to cast their votes again thereat.
- f) Members who have not casted their votes through remote e-voting may cast their vote at the AGM through Ballot Papers.
- g) Mr. Pravin Kumar Drolia, Practicing Company Secretary (FCS-2366/CP-1362) of M/s. Drolia & Co., Company Secretaries, Kolkata, has been appointed as the Scrutinizer to scrutinize the remote e-voting process and physical ballot process at the AGM in fair and transparent manner.

The results declared alongwith Scrutinizers' Report shall be placed on the website of the Company i.e. www.somanyceramics.com and on the website of CDSL i.e. www.cdslindia.com for information to the Members, besides being communicated to Stock Exchanges at BSE& NSE. Subject to receipt of requisite number of votes, the Resolutions set out in the Notice of AGM, shall deemed to be passed on the date of AGM i.e. 2nd September, 2016.
